O R D E R

The application for affiliation of new Arts & Science  
colleges from various Educational Agencies for the academic year  
2004-05 had been processed and considered by the University as  
per the provisions in the Act and Statutes and recommended to  
the Government for consideration.

The Government vide order read (3) above, have accorded  
sanction to the following five Educational Agencies to start  
new Arts & Science colleges in the un-aided sector during the  
academic year 2005-'06 with the courses noted below. The Sub-  
Committee of the Syndicate on Affiliation held on 29/4/2005  
resolved to recommend to grant provisional affiliation to the  
colleges applied for by the Educational agencies.

The Syndicate at its meeting held on 20/5/2005 vide item  
No. 2917 approved the above recommendation.

Sanction is, therefore, accorded to the following five  
Educational Agencies being granted Provisional Affiliation to  
start new Arts & Science colleges with the courses listed below  
under the unaided/self-financing sector during the academic year  
2005-'06.

The Provisional Affiliation granted is subject to the following conditions:

1. The provisional affiliation granted is initially for a period of one academic year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subject concerned.

3. The admission in the above courses shall be made as per the approved schedule following the existing rules of admission as follows:

- (a) Fifty percent of the seats in each course shall be filled by the Management from candidates of their choice provided they satisfy the eligibility conditions prescribed by the University for admission to the said courses.
- (b) Sixty five percent of the remaining seats shall be filled on general merit and thirty five percent shall be filled by the candidates belonging to the following communities.

4. The Educational Agencies shall forward the attested copies of the following documents within two weeks from the receipt of the order.

- (a) The title deeds of the proposed colleges
- (b) Latest Encumbrance Certificate from the Sub Registrar
- (c) Latest Tax Receipt of the proposed land
- (d) Sketch & Plan of the plot of the proposed college site from the Village/Municipal Offices
- (e) Sketch & Plan of the building.

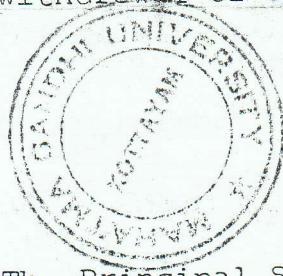
5. The Management shall remit all the fees due to the University as follows.

6. Collection of Annual Administration Fee from the students under any circumstances is not permitted.

7. Students' Affiliation Fee collected on one time basis from all students @ Rs.200/- for U.G. and @ Rs.250/- for P.G. shall be remitted to the University within fifteen days after closing of the admission.

8. The Educational Agency shall remit an amount of Rs. 1,00,000/- (Rupees One lakh only) towards the initial affiliation fee for the new college.
9. The Educational Agency shall furnish a Financial Guarantee for an amount of Rs. 3,00,000/- (Rupees three lakhs only) by way of the following:-
- Cash deposit by way of Chalan/DD
  - Fixed Deposit in the State Bank of India or in any one of the Nationalized Banks, having Aquisition and Transfer of undertaking. The receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
  - Government Securities
  - Saving Certificates, National Postal or Defence Bonds in favour of the Finance Officer.
  - Mortgage of the title deeds of immovable property other than the college sites, building/hostels where such mortgage is permitted under any law for the time being in force.
10. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs.50/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinances and Regulations and the directions issued by the University, from time to time, in so far as they are related to the college. The undertaking shall be endorsed by the Principal of the college.
11. Non-compliance with any of the above conditions would lead to the withdrawal of affiliation without any notice.
