legal enthusiasts, and students keen on delving into the nuances of IPR gathered to absorb the expertise shared by Ms. Arya.

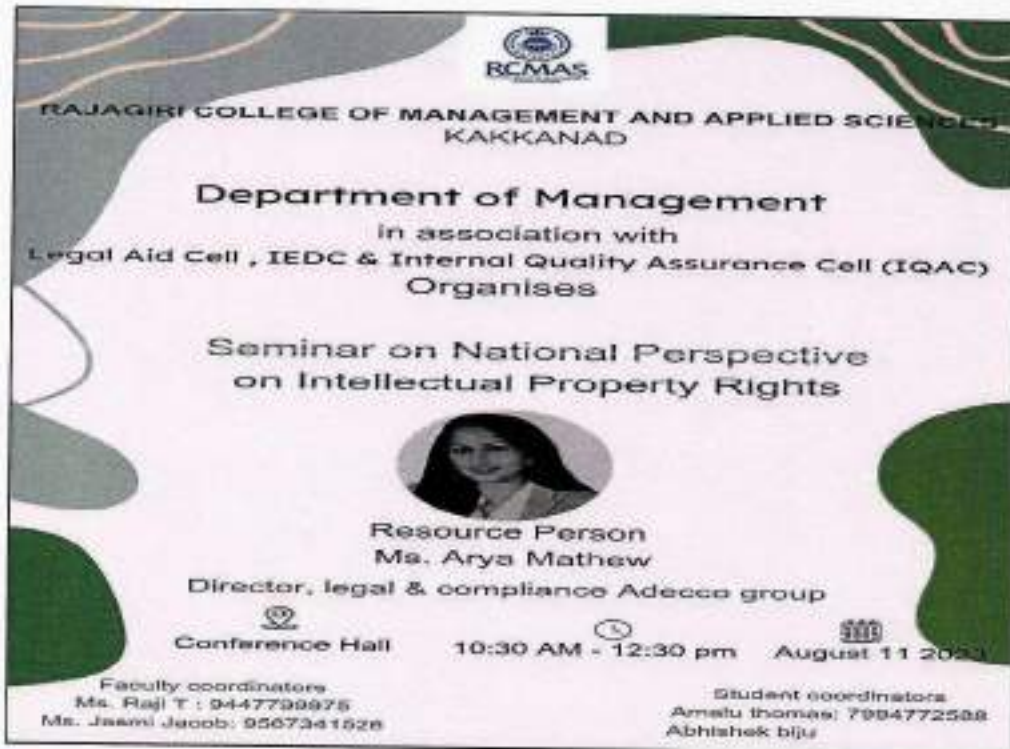
