Anti-Ragging Committee

In accordance with the UGC Regulations of 2009 on curbing ragging in higher educational institutions, the college has established an Anti-Ragging Committee to monitor and prevent incidents of ragging on campus. One such measure is the mandatory submission of anti-ragging affidavits by students and parents through https://www.antiragging.in. Additionally, the institution ensures compliance with anti-ragging regulations by monitoring various strategic campus locations with surveillance cameras. Regular communication, mentoring, and counseling sessions with students are also conducted to detect early signs of ragging and identify potential issues. The college has constituted the Anti Ragging Committee, as per the norms, to prevent and prohibit the incidents of ragging on campus.

The responsibilities of the committee include the following:

- To prevent the issue of ragging and encourage positive relationships among students on campus.
- To maintain constant surveillance to prevent occurrences of ragging.
- To address and handle incidents of ragging reported to the college firmly and appropriately.
- To provide counselling services and raise awareness among students.


