

## **Anti-Ragging and Ethics Committee 2023-2024**

#### Anti-Ragging and Ethics Committee

As per Menace of Ragging in Higher Educational Institutions, 2009, UGC has ramed regulations in order to prohibit, prevent, and eliminate the scourge of gging. In pursuance to the Judgment of the Honble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Com ussion Act, 1956, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" These regulations are mandatory for all universities/institutions.

#### What Constitutes Ragging?

#### Ragging constitutes one or more of any of the following acts:

- Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating, or handling with rude ness a fresher or any other student.
- indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psycho logical harm or to raise fear or apprehension thereof in any fresher or any
- Asking any student to do any act which such student will not in the ordinary ourse do and which has the effect of causing or generating a sense of shame, or torment or embarrassment to adversely affect the physique or psyche of such fresher or any other student.
- ny act by a senior student that prevents, disrupts, or disturbs the regula

- Any act of financial extortion or forceful expenditure burden put on a fin or any other student by students.
- Any act of physical abuse including all variants of it: sexual abuse, home sexual assaults, stripping, forcing obscene and lewd acts, gestures, caush bodily harm or any other danger to health or person;
- Any act or abuse by spoken words, emails, post, public insults which we also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any on student.

- other student with or without an intent to derive a sadistic pleasure of showing off power, authority, or superiority by a student over any fresher

#### Punishment Provisions:

Any student or group of students found guilty of ragging on campus or campus shall be liable to one or more of the following punishments:

- Debarring from appearing in any sessional test/ university examination withholding results
- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits Suspension from the college for a period of one month
- Cancellation of admission
- Debarring from representing the institution in any national or internation
- meet, tournament, youth festival, etc Suspension/expulsion from the hostel Rustication from the institution for periods varying from 1 to 4 semester
- or equivalent period Expulsion from the institution and consequent debarring from admission to any other institution
- Fine up to twenty-five thousand rupees
- Imprisonment for a term which may extend to two years or with fine when the same of the sa may extend to ten thousand rupees or with both
- Collective punishment When the students committing or abetting the crime of ragging are not identified, the institution shall resort to collect


