2.Scope:

Removal and Disposal of E-waste, Plastic, Wastepaper from **RAJAGIRI COLLEGE OF MANAGEMENT AND APPLIED SCIENCES, KAKKANAD** Premises listed below according to the guidelines prescribed by relevant State & Central Government Board/Authority

3.Place of Performance:

RAJAGIRI COLLEGE OF MANAGEMENT AND APPLIED SCIENCES

4.Compliance with all relevant laws

4.1 The Buyer should comply with all the requirements of Pollution Control Board and other relevant laws in force as may be applicable in relation to collection, transportation, processing and disposing of E-waste, Plastic and Waste paper

4.2 The Buyer should ensure that the vehicle drivers carry proper licenses, permits, trip sheets and tram cards during the journey.

4.3 The Buyer should take due responsibility for proper disposal of the hazardous E-Waste ,plastic and Waste paper as per the norms laid down by the State/Central PCB.

4.4 All documentations necessary for the smooth transportation of material should be completed by the Buyer.

5.Delivery to be taken as per the following schedule

5.1 The materials should be lifted from **RAJAGIRI COLLEGE OF MANAGEMENT AND APPLIED SCIENCES** at least once in 6 months. On receipt of the order, **RAJAGIRI COLLEGE OF MANAGEMENT AND APPLIED SCIENCES** have to intimate **MICROAGE NETWORKS AND SOLUTIONS** the schedule for lifting the material for enabling the college to keep the materials ready for disposal.

5.2 Delivery of materials will not be made on Saturdays, Sundays and other holidays.

5.3 **RAJAGIRI COLLEGE OF MANAGEMENT AND APPLIED SCIENCES, KAKKANAD** is not responsible for any injuries caused due to accident/ negligence with in the premise or at the place of work to the buyers or his representatives or labourers and the buyer shall make proper arrangements for such eventualities. It is the responsibility of the buyer to provide all safety appliances to the labourers who are engaged in loading of the material.



6. Terms of Implementation:

6.1 Details of the implementation or revision of any exchange resulting from this MoU for cooperation shall be negotiated between the parties.

6.3 The MoU can be renewed/ terminated prior to 30 days notification period of the validity period, if any party wishes to do so.

6.4 Sale of E-waste to MICROAGE NETWORKS AND SOLUTIONS, will be made Free of Cost.

6.5 Sale of papers and Plastic will be made at Market Price.
